

Harbour and camping regulations

May 2025

These regulations apply to all areas and facilities of the Marina and Camping De Domp Foundation. The starting point is that we jointly ensure safety and prevent nuisance.

General rules

- Anyone who is on the grounds must follow the instructions of the harbour master and also the rules of these regulations.
- In the harbours and on the grounds of De Domp, advertising for any purpose is not permitted without written permission from the board. The same applies to the sale of goods..
- In our parking areas, parking is only permitted within the designated spaces. The areas must always be kept accessible for emergency services.
- Outside the parking areas, parking is only permitted after permission from the harbour master. This also applies to the parking/storage of trailers and semi-trailers.
- In the interests of safety, driving on the grounds must be done at walking pace.
- Electric cars may only be charged at charging stations provided for this purpose and not at regular 230 volt connections on the grounds.
- Dogs are allowed on the grounds, provided they are kept on a leash. Excrement must be cleaned up immediately by the person walking the dog.
- The use of barbecues and cooking appliances is permitted, except on the jetties, provided they are placed safely and sufficiently above the ground. No danger, damage or nuisance may be caused. Other forms of open fire and fireworks are not permitted.
- The drinking water taps on the grounds are only for taking in drinking water and are not used for cleaning cars, ships or camping equipment, for example.
- Cycling on the jetties is not permitted.
- Noise on the grounds must be kept to a minimum between 22:00 and 08:00. Any form of nuisance must be avoided.
- The sanitary facilities must be kept tidy and the grounds must be cleaned up.
- Waste must be separated into components as indicated on the waste containers. Only normal household and recreational waste may be deposited in these containers.
- Excessive use of alcohol must be avoided and possession or use of drugs and/or laughing gas is not permitted.
- Aggression, threats and use of violence, discriminatory remarks, sexual harassment and public urination will not be tolerated and may result in immediate removal of the person concerned.
- Boat passers-by or campers who arrive after 6:00 PM can consult the information at the entrance to the reception.
- Damage caused to property of the Foundation or third parties must be reported to the harbor master immediately. This also applies to situations in which damage may occur.
- Persons under 18 years of age may only stay overnight on our grounds or on board ships as part of a family.
- The rates for the use of our grounds and/or harbours by passers-by or camping guests are stated on the website www.dedomp.nl

Additional rules for the harbours

- Moorings are assigned by the harbour master.
- Toilets that discharge into open water may not be used and bilge water may not be pumped overboard into surface water.
- Batteries for the electrical propulsion of a ship may only be charged after prior consultation with the harbour master and under the conditions that he/she sets for this. This rule does not apply if a power connection is used via AanUit.net
- In the harbours it is mandatory to sail slowly. On arrival and departure, the shortest route to and from the mooring must be taken. Running engines and ship propellers must be limited as much as possible. - Swimming and playing with boats and dinghies in the harbours is not permitted to prevent unsafe situations.
- The assigned berth for passers-by can be used until 12:00. Extending your stay must be agreed with the harbour master before 11:00.

Additional rules for the campsite

- Camping and camper pitches are assigned by the harbour master.
- No other vehicle, except bicycles etc., may be parked on a pitch for a camper.
- At the assigned pitch/accommodation for a camping vehicle (such as a caravan) and at the hikers' cabins, 1 car may be parked for a short time for the purpose of placing a camping vehicle and/or direct loading and unloading. No cars may be allowed on the tent field.
- Batteries for the electric drive of a camping vehicle may only be charged after prior agreement with the harbour master and under the conditions that he/she sets for this.
- From 13:00, you can check in for a pitch on the campsite; On the day of departure, the assigned space can be used until 11:00.
- After 11:00 on the day of departure, the car or camping equipment can be parked in the municipal parking lot outside the harbor and camping site if necessary.

Final remarks

- The Rental Regulations also apply to permanent berth holders of the Marina and Camping De Domp Foundation.
- Additional rules may apply for certain periods (e.g. the Sneekweek).
- In situations not provided for in these regulations, the harbour master will decide.
- The harbour master is authorized to (have) guests removed from the harbours or from the camping site without refunding mooring or camping fees. The harbour master applies this authority if these regulations are not complied with, there is a nuisance and the person concerned has first been warned.
- The Foundation is not liable for damage of any nature or by any cause whatsoever to persons or goods or for loss or theft of any property.
